Good news.

For us, as I said earlier, the most interesting is the catalogue of disciplines, in which the competences and program learning outcomes are indicated for each discipline.

It is very good that KNEU fulfils the requirements of the new law on higher education and prepared for each discipline its vision of the program learning outcomes.

This is a very big step forward compared to other universities. The precise formulation of competencies and learning outcomes is not an easy task and requires highly qualified teachers.

Bad news.

The competences and results of training should be formed in close cooperation with employers.

Obviously, this was not done.

From our point of view, all learning outcomes must be measurable; are formulated as concretely as possible.

The short analysis of the received document shows that at least half of the learning outcomes are very general and can hardly be checked during examinations or tests.

But I want to emphasize once again that the appearance of such a catalogue in the framework of our project is a very big step forward for Ukrainian universities.
