MSc Seminar - Summer term 2020

Seminar description

In this seminar we will discuss (recent) frontier research in family economics. The range of topics includes taxation of households/families, divorce, child well-being, childcare, effects of parenthood on labour market outcomes, fertility, and transmission of disease. We will study several research papers that utilize empirical techniques and economic modelling to provide evidence on recent significant changes in household choices and family structure and to understand the forces behind those changes. Studying the economic determinants of families is important for at least two reasons: first, decisions within the family can have long-run effects on aggregate economic outcomes such as growth and inequality in an economy. Second, it is crucial to understand the effects of and (optimal) design of policies related to e.g. parenthood, childbearing, divorce, taxation of families and households.

Basic information

Requirements: The registered participants in the seminar are expected to give a presentation of around 50 minutes on one of the topics listed below. They could use as a base for the presentation a paper listed under the topic and summarize, critically evaluate, and compare it to the related literature. In addition to that, they need to submit a 10-15 pages term paper. The final grade is based on the seminar paper (50 %), the presentation (40%), and active participation in class (10 %) where students present their work.

Selection of topic/paper: Students who have received a slot in the seminar should send me a list of at least 3 papers ranked by their preferences (david.koll@uni-konstanz.de). Based on that, I will then assign topics/papers to all participants.

Presentations: The presentations will take place on Friday May 15th and Saturday May 16th 2020, 9:00am - 6:00pm, Room tbd (mandatory participation)
